 - Learning. Student Achievement and Effective Teaching
 - Goal 1A.1: By 2025, 50% of KCPS 3rd graders will be reading at or above grade level as measured by iReady or district approved universal screener, increasing to 70% by 2030.
 - Goal 1A.2: By 2025, KCPS will increase the percentage of students scoring in the top three performance bands on the ELA MAP and EOC assessments by 20%, and by an additional 15% by 2030.
 - Goal 1B: By 2025, 50% of students performing below grade level will attain their annual growth goals in reading and math as established by student performance on iReady or district approved universal screener, increasing to 75% by 2030.
 - Goal 1C: By 2025, the four-year high school graduation rate will be 80%, increasing to 85% by 2030.
 - Goal 1D: By 2025, 75% of eligible graduates will attain at least one Market Value Asset (MVA) in their plan of study, increasing to 100% by 2030.
 - Goal 1E: By 2025, the proportional attendance rate will be 80%, increasing to 85% by 2030 through an enhanced student experience.
 - Goal 1F: By 2025, KCPS will increase the percentage of students scoring in the top three performance bands on the Science MAP and EOC assessments by 25%, and by an additional 15% by 2030.
 - Goal 1G: By 2025, the percentage of students scoring in the top three performance bands on the Math state assessments will increase by 20%, and by an additional 15% by 2030.

- Facility Recommendations
 - Revised Recommendations:
 - 35 of the 37 currently operating KCPS schools are recommended for continuation
 - 2 currently operating schools are recommended for closure and/or conversion next school year
 - Longfellow Elementary and Troost Elementary
 - No new schools designated for creation/establishment
 - Pursue General Obligation Bond in the Spring of 2024
 - Revisit additional facility recommendations after further engagement and bond vote
- Longfellow Elementary
 - Building score of 3.74 means cannot continue with this building in the long term
 - Continued discussion with the Longfellow community/student body to make sure new placement can be made and in certain cases students can be placed together
 - More parental community engagement
- Troost Elementary
 - Building score of 5.82
 - Small classrooms
 - Under utilized
 - Decline in student enrollment
 - Continued discussion with the Troost community/student body to make sure new placement can be made and in certain cases students can be placed together

 - Will not change signature school programs, will only update neighborhood school programs. Moving neighborhood schools into alignment. Moving 6th grade students out of elementary schools and into middle schools
 - Instrumental music for 4-6 will move forward
 - Montessori programs will be discussed with the principal and staff of these schools regarding the 3-year cycle within the programs

- Superintendent search
 - Using attributes to rank possible candidates
 - Shall announce final decision by end of February
- School board
 - 4 vacant seats
 - Candidate Filing for Sub-Districts 2 & 4 and the one At-Large position are closed.
 - Jamekia Kendrix is the only candidate for Sub-District 2
 - Josh Jackaway is the only candidate for the At-Large Seat
 - There will be space for Write-In Candidates on Sub-District 4
 - Sub-District 3 candidate filing period is February 21-March 14. There will be a School Board School on February 4, 9:30am-12pm. The election will be June 20.

- What is the district's plan for recruiting and retaining teachers?
- o Dr. Collier: will take this question to chief HR representative for the district

• Foreign Language Academy

- Learning management system like canvas to get students ready
 - Dr. Collier: Working now to secure a learning system, possibly Canvas
- Second question: Math and literacy programs implemented this year. What is being implemented in class?
 - Dr. Collier: math interventionist and reading interventionist allocated to each building. Sending teachers through letters training, number training. Will earn reading and math endorsements. Tutoring across buildings. Contract to provide high dosage tutoring in Tier 3 schools. KCPS Loves to Read Program. Literacy academic vocabulary and close reading strategies are also slated for next year.

African Centered College Preparatory Academy

o Transportation issues. Students that are not picked up by buses in the morning





- Students picked up late, getting home late at night
- O What is the process for correcting the issue?
 - Dr. Collier: transportation has lost staff again, looking to work with second transportation company to breakdown the number of routes each company has

Holiday Montessori

- 6 grade year for their kids
- Many kids want to move on to Lincoln Prep
- If they wait until 7th grade, they are waitlisted
 - Dr. Collier: students in KCPS have high weight in lottery process. Looking at issues with 7th grade waitlist

Foreign Language Academy

- SafeStop app works when regular bus is driving route but not when there is a substitute bus
- o Lack of lights in the FLA lower parking lot
 - Work request put in 2 years ago. 6 of 8 lights in the parking lot do not work

James Elementary

- o More security possibly needed. Currently have 1 or 2 security guards
- Would prefer around the clock security
- Food: more nutritious food needed. More fruits and vegetables
 - Dr. Collier: none of the elementary schools have an ongoing presence in and around the building. That type of presence is in middle and high schools

East High School

Many families who are bilingual, some in the process of being able to respond.
 Possibly more specialist who are bilingual who can help with information
